Moved by J. Beder and seconded to amend section 7.1 of the Faculty Council By-laws to include the Secretary as a member of the Executive Committee as follows:

Membership. The Executive Committee shall include the Speaker, Vice-Speaker, Secretary and one Faculty Council Representative from each undergraduate and graduate faculty body not already represented by the Speaker, Vice-Speaker, or Secretary. Each faculty body may decide how to elect or appoint its Executive Committee Member.

Faculty participation in three newly forming committees, the "Josh Joseph" Committee, Provost Search Committee and Tenure Review Committee, was discussed. Members of the Executive Committee along with other faculty, deans and administrators will meet with Josh Joseph on May 3. The Faculty Council elected Nancy Beckerman, Anatoly Frankel and Joanne Jacobson as faculty representatives to the Provost Search Committee through electronic balloting concluded on March 1. Nominations for the Tenure Review Committee should be submitted to L. Wishart.

- P. Geyh reported on the results of the Survey of Yeshiva University Faculty on Faculty Retirement Plans and Benefits. The Survey collected 128 responses from tenured, tenure-track and clinical faculty during the period April 10-23, 2013.
- J. Beder reminded Representatives to be thinking of nominees for the positions of Vice-Speaker and Secretary prior to their election at the first Faculty Council meeting in the fall.
- M. Lowengrub and L. Schiffman joined the meeting at 12:10 pm. The Provost suggested that the Faculty Council make a presentation to the Academic Affairs Committee of the Board of Trustees. The Faculty Council reconvened in Executive Session at 1:25 pm.
