Application for Directed Study

Under special circumstances, students in need of a course listed in the Catalog but not currently offered are permitted to take the course by directed study. Approval is granted on an individual basis and the privilege is limited. Except under the most unusual circumstances a student may take only one Directed Study course per semester. For undergraduates, the student must be a senior, or, with special permission, a junior, with a minimum average of 2.5.

Procedure:

- 1. Student completes Part I and submits form to faculty sponsor.
- 2. During the first two weeks of the semester in which Directed Study takes place, the student must submit this form, signed by the faculty sponsor, as well as a student copy of his or her transcript to the Office of the Dean.
- 3. The Dean considers each application and must approve it before work begins.
- 4. At the end of the term, the instructor submits a grade to the Registrar. The course is listed on the student's record with its regular number and title.
- 5. Directed Study may be done during the summer, with permission of the faculty sponsor and the Dean of the college. There is a per-credit charge for such work.
