One of the topics we will be discussing is the rise of the global "AI bubble." Over the past few years, billions of dollars have been poured into AI startups and projects¹, with companies racing to release the newest models and tools. While innovation has been exciting, concerns are growing that development is happening too fast, with limited regulation and oversight. Issues such as job loss, misinformation, and safety risks are already becoming clear,

and some experts warn that the current wave of AI investment may not be sustainable.² CSTD must explore how to balance innovation with caution, and whether international cooperation is needed to prevent the bubble from bursting in a way that harms economies and societies around the world.

Another topic we will be discussing is the spread of deepfakes and AI-generated disinformation. As artificial intelligence grows more advanced, images, audio recordings, and videos can be manipulated to look and sound incredibly real. These deepfakes are blurring the line between truth and fiction, threatening elections, undermining trust in the media, and even putting individuals at risk.³ Delegates must consider whether the UN should push for a global framework to manage and label AI-generated content, forging a balance between protecting public trust and maintaining space for creativity and innovation.

You, as delegates, will be challenged to think critically about how your countries view these issues, and to craft resolutions that balance technological advancement with global equity and security.

I strongly encourage you to thoroughly research these topics so that we can have productive discussions and work together to create resolutions to these pressing issues. When preparing your position papers and slideshows, remember that you are representing your assigned country's perspective, not your own. Please also provide citations and note that all papers will be submitted through Turnitin and AI detectors. Plagiarism (including ChatGPT) will not be tolerated.
