CSW: Topic #2 - Domestic Violence Against Women

The second topic that the CSW will focus on is the **response to domestic violence against women**. Domestic violence, according to the World Bank Group, is defined as "a pattern of behavior in any relationship that is used to gain or maintain power and control over an intimate partner." While commonly referred to as domestic violence, it is also labeled domestic abuse or intimate partner violence. ¹

Many women have a limited understanding and definition of what domestic abuse is and presents as, and so they may become trapped in situations where their lives may be at stake. This may be due to limited access to resources or a cultural stigma as to what can be identified as domestic violence, causing women to excuse dangerous or abnormal behavior.

As a result, domestic violence has become one of the leading issues facing women globally, making finding urgent solutions critical. The World Health Organization reported that "over a quarter of women aged 15–49 years who have been in a relationship have been subjected to physical and/or sexual violence by their intimate partner at least once in their lifetime (since age 15)." In some situations, a woman's safety may be endangered when her partner resorts to lethal violence in response to her rejection of his control or dominance. The effects of these behaviors leave lasting damage to a woman's well-being and prevent women from using their abilities in society. It can also contribute to suicidal ideation and other mental health challenges.

Although various approaches have been made to fix this problem, none have been entirely successful. With the UN Women's "Ending Violence against Women" Act putting the issue on the table, it is time to make a shift. It is now essential to take concrete actions to better protect women against these acts of violence.³

Given the severity of this issue, the global community must find a more substantial resolution for future generations.
