The Commission on the Status of Women (CSW) stands as the global intergovernmental body dedicated to ensuring women's equality and promoting women's rights. Their establishment began in 1946, when CSW was declared a functional commission under the Economic and Social Council (ECOSOC). Their goal following their establishment was to reform discriminatory legislation and to create a global awareness of women's issues. Specifically, they focused on equality in all places of the world, documenting a country-by-country guide of the legal and political status of women.

They were quick to action, hosting many conferences and events during the World Conferences that followed their establishment. To celebrate their 25th anniversary, CSW declared



1975 International Women's Year, aiming to raise awareness of the discrimination against women that was deeply rooted in international cultural and legal beliefs. They continued to bring these issues to the following World Conferences; they expanded to topics such as violence against women and women's health. In 1995, CSW was assigned by ECOSOC to oversee the Beijing Declaration and Platform for Action, which led to advancing gender equality and women's rights worldwide. Most importantly, in 2011, the United Nations decided to consolidate four parts of its system to form UN Women, which now serves as the Secretariat for CSW. Today, CSW continues to monitor the Beijing Declaration and Platform Act, and meets annually to discuss how to continue to progress and monitor gender equality and women's rights.<sup>1</sup>

In this year's conference, we will be discussing two topics. Specifically, women in leadership roles and domestic violence against women. Each of these topics is immensely important, and I have faith in you, delegates, that you will each come to a resolution to solve these issues. This will require thorough research based on your country's position, which will help you craft your position papers and properly participate in discussions.

Please be mindful in your usage of outside sources, and remember to cite where you have found your information; there will be no tolerance for plagiarism. We will also be putting all submitted documents through AI detection devices, given our zero-tolerance policy for AI usage.
