Course Description: This course will explore foundational questions in the epistemology of religion. Some of the questions are very old: can we know that God exists, and if so, how? Can we reasonably believe in God in the absence of evidence, and if so, why? Is it better to know that God exists or to accept it "on faith"? What is faith, anyway? Some of the questions are of more recent vintage: does the fact of religious disagreement between apparently reasonable people undermine everyone's religious knowledge? How about the fact that if religious folks had been raised in a non-religious home, they very likely would not be religious? The readings will be drawn from both the Western and the Jewish philosophical and theological corpora.

- Twenty Pre-Class Question Submissions (1.5% each, 30% total)

Paper: You are required to write a paper (~ 12 pages), the subject of which can be any topic closely related to one we cover during the semester. (Note: every topic is closely related to itself.) Although the choice of topic is yours, you need to run it by me first for approval. The paper is due the day of the final exam.

Twenty Pre-Class Question Submissions: You are required to submit twenty-fours hours in advance of (nearly) every class session two questions about the readings you are assigned for that class. I say 'nearly' because there are twenty-six class sessions and you are required to submit questions before only twenty class sessions. (You decide on which occasions not to submit questions.) These questions will be submitted through Angel, and will be available to all participants in the class. They will form the basis of part of our in-class discussion.

Attendance & Participation: Attendance is required. A student is permitted two unexcused absences. Good participation includes, but is not limited to, asking questions, attentively following the class, and meeting with me during office hours.
