Two Advanced, Specialized Learning Tracks For You

Our residency positions are available in two specialty tracks.

Early Childhood Mental Health (ECMH)

6 positions

Residents in the ECMH track will focus on work with babies, toddlers, young children aged 0-7, and their families and receive:

- Training in early childhood mental health foundational competencies
- Evidence-based model trainings: Child Parent Psychotherapy (CPP) and Facilitating Attuned Interactions (FAN)
- Reflective Supervision
- Placement at one of our Early Childhood clinics

Dialectical Behavior Therapy (DBT)

10 positions

Residents in the DBT track will focus on work with clients from adolescence through adulthood who will benefit from DBT services and receive:

- Training in foundational clinical competencies relevant to DBT
- Comprehensive training in standard DBT
- Training in DBT with Multi-problem Adolescents
- Placement at one of our clinics

Applicant Eligibility Requirements

All applicants must be current social work student in the final year of an accredited MSW program or recent MSW graduate who completed their degree from an accredited program no earlier than January 1, 2022, and:

- Currently reside in or plan to reside in the NY Tri-State area throughout the three-year duration of the Social Work Residency
- Be vaccinated against Covid-19: As part of our continued efforts to maintain a safe workplace for employees, interns, volunteers, clients, and their families, all employees, interns, and volunteers must provide one-time verification or proof of full COVID-19 vaccination to Human Resources.
