

Dear Delegates of the Security Council<sup>1</sup>,

Welcome to the first step of your YUNMUN XXVIII<sup>2</sup> journey!! My name is Rena Kleiner<sup>3</sup>, and I am beyond honored and excited to be serving as your chair of the Security Council this year.

At this year's conference the Security Council will be working slightly differently than it has in years past as I am sure you have noticed seeing as the topics our committee will be discussing are: Denuclearization of North Korea and an Open Agenda. All information necessary to understand how the Open Agenda will work can be found in the topic paper itself. But enough about you and me, let's get down to business to defeat the Huns.

The United Nations Security Council (UNSC) was founded in 1946, and takes permanent residence at the headquarters of the United Nations in New York City. As one of the six main organs of the UN, the UNSC has four main purposes, "to maintain international peace and security; to develop friendly relations among nations; to cooperate in solving international problems and in promoting respect of human rights and to be the centre for harmonizing the actions of nations."<sup>6</sup> As required per the UNSC charter, all members of the UN are obligated to accept and implement any decisions of the Security Council as opposed to the other organs of the UN. The UNSC has five permanent members and ten elected non-permanent members that rotate every two years<sup>7</sup>. The victors of World War II, Russia, United States, United Kingdom, France and China make up the five permanent members of the committee, otherwise known as the "P5"<sup>8</sup>. These members have unlimited veto power over any resolution proposed in the UNSC including candidates for
