THIS AGREEMENT made this 22nd day of September, 1911, by and between The Procter & Gamble Company, a corporation, party of the first part and Sender Lifnitz of Cincinnati, Ohio, and M.S. Margolies of New York City, rabbis of the Jewish Religion, parties of the second part, WITNESSETH:

WHEREAS, the party of the first part is engaged in the manufacture of a vegetable shortening known as CRISCO and is desirous of obtaining from the parties of the second part their certificate that said CRISCO contains no animal substance or other substance which is objectionable to the Mosaic Dietary Laws; and,

WHEREAS, parties of the second part are willing to furnish such certificate upon the terms and conditions hereinafter set forth:

NOW THEREFORE in consideration of the premises the parties hereto hereby agree as follows:

1. The parties of the second part shall at once cause the said product CRISCO to be chemically analyzed and if found to conform to the Mosaic Dietary Laws shall issue their certificate to that effect to the party of the first part; the party of the first part shall cause as many copies of said certificate to be made as are necessary in its business and shall serially number such copies; party of the first part shall cause a copy of said certificate to be affixed to each can or receptacle containing CRISCO that is intended for the Jewish trade, said certificate to be so affixed to each can or receptacle in such manner that it will be destroyed upon the opening thereof.

Said certificate shall continue in force until and unless revoked by the parties of the second part as hereinafter provided.

2. The parties of the second part shall at all reasonable times through themselves, or agents or employees, have the right

to enter and inspect any or all parts of the factory in which said CRISCO is manufactured and shall have the further right at all reasonable times to take any samples of any raw materials entering into the manufacture thereof, or of the finished product

The party of the first part shall at all times keep the factory wherein said CRISCO is manufactured in such condition as will comply with the said Mosaic Dietary Laws according to the interpretation thereof by the parties of the second part.

3. In case the parties of the second part shall determine at any time that said CRISCO does not conform in any respect to the aforesaid Mosaic Dietary Laws, they shall at once have the right to revoke the certificate hereinabove mentioned and to announce the fact throughout the public press and on and after such revocation duly certified to the party of the first part, party of the first part shall at once cease printing said certificates and cease affixing the same to its cans or receptacles containing said product.

The parties of the second part shall have the sole right of interpreting the aforesaid Mosaic Dietary Laws.

4. This agreement shall continue in force for a period of one (1) year from and after the date hereof and thereafter until cancelled by either of the parties hereto upon giving to the other thirty (30) days notice in writing to that effect.

5. The party of the first part shall pay to the parties of the second part the sum of one hundred and twenty-five (\$125.00) dollars per month for the purpose of the employment of inspectors, expenses, analyses, etc. during the continuance of this contract; such payment shall be made upon the last of each and every month to the aforesaid Sender Lifszitz, 531 Richmond Street, Cincinnati, Ohio.

6. This agreement shall enure to the benefit of and be binding upon the parties of the second part hereto and their successors in office as rabbis of the Jewish Community and upon the party of

the first part, its successors and assigns, and also upon The Procter & Gamble Distributing Company and The Procter & Gamble Manufacturing Company, and their respective successors and assigns; in case of the death resignation or incapacity of any of the parties of the second part the remaining one shall have the right to designate his successor.

IN WITNESS WHEREOF the parties hereto have executed this agreement this 22nd day of September, 1911.
